## **CODE OF CONDUCT**

## All youth and adult participants are expected to abide by the following:

- 1. The Scout Oath and Law will be my guide throughout the East Fork District Cub Scout Day Camp.
- 2. I will set a good example by keeping myself neatly dressed and presentable. (The official Day Camp T-shirt or another Cub Scout T-shirt should be worn each day, along with shorts/pants, socks, and closed toe shoes).
- 3. I will participate as required in cooperation with other Scouts and leaders.
- 4. Serious and/or repetitive behavior violations by youth, including inappropriate behavior between male and female participants, use of tobacco, cheating, stealing, dishonesty, swearing, fighting, and cursing, may result in expulsion from the Day Camp or loss of privileges. As an alternate to expulsion, parents may be asked to attend Day Camp with their Cub Scout for the duration of the week. The Camp Directors must be contacted and are the final deciding authority on determining if a participant or staff member will be asked to leave camp or if a parent will be required to attend. There are no exceptions.
- 5. I will be responsible for keeping my personal gear with me or in at my Den Tent at all times.
- 6. I understand that possession of knife of any type by a Cub Scout is prohibited and is grounds for expulsion. Pocketknives will be provided by Day Camp for use by AOL Scouts with a signed Whittling Chip for designated activities.
- 7. I will adhere to all Day Camp garbage and recycling policies and regulations. I will do my share to prevent littering of the Day Camp grounds and understand that it is my responsibility to pick up trash when/if I see it even if it is not mine.
- 8. I understand that the possession or consumption of alcoholic beverages or illegal drugs by any participant in the Day Camp is prohibited. This standard shall apply to all participants and staff—both youth and adult leaders.
- 9. I will demonstrate respect for personal and Day Camp property and be personally responsible for any loss, breakage, or vandalism of property as a result of my actions. Deliberate destruction of property will be grounds for expulsion.
- 10. Neither the adult leadership nor the Dan Beard Council, BSA, will be responsible for loss, breakage or theft of personal items. I will label all my personal items and leave items of value at home. Theft will be grounds for expulsion.
- 11. Adult and Youth Staff will be guided by the Scout Oath and Scout Law and will obey all U.S., state and local laws.
- 12. Adult and Youth Staff must receive Youth Protection training and follow the guidelines therein prior to Day Camp training.
- 13. Hazing has no place in Scouting; nor do running the gauntlet, belt lines, or similar physical punishment. Adult leaders, youth staff and participants must prevent any youth from being "initiated" into the dens with hazing.
- 14. I understand that violation of this code may result in my expulsion from the Dan Beard Council Day Camp at my family's expense and without a refund, and that all decisions by the Day Camp Directors will be final.
