

## **GOOD SCOUT AWARD LUNCHEON**

- The Good Scout Award Luncheon is the largest fundraising event held by the Dan Beard Council, raising nearly \$4.3M over the past 10 years to support Scouting in Greater Cincinnati and Northern Kentucky alone.
- It is regularly recognized as one of the largest and most successful charitable events in our region. It provides a unique opportunity to celebrate Scouting while recognizing a local organization for their generous support of the community, and highlights a strong partnership with local corporations and community leaders.
- Past honorees have successfully integrated their corporate brand with that of the Dan Beard Council through event concept, theme, and marketing materials.
- The program includes participation by local Scouts, a nationally known keynote speaker, and the annual presentation of the Good Scout Award to an area business/community leader who exemplifies corporate citizenship.
